## TRUE CODE TRAVEL AGENCY ACCREDITATION

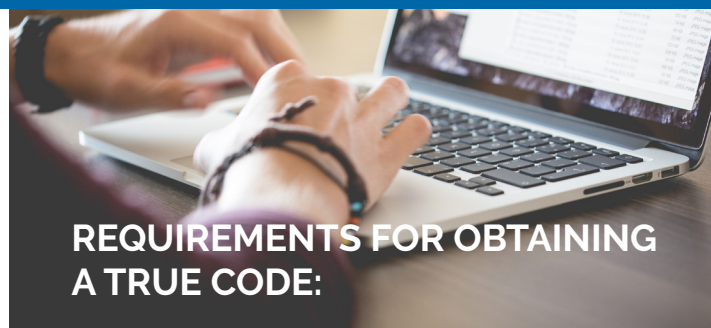

### How the TRUE Code Works

The TRUE (Travel Retailer Universal Enumeration) Code is assigned to a travel agency that meets all qualifications and satisfies a rigorous screening to ensure the integrity of the program

This code is then used to identify your agency with suppliers for commission payment and sales volume tracking. That means you're recognized directly - not as part of a pool of other agents. You're building your own relationships with the suppliers that meet your needs.

**Even if you work with a host agency today, you can still use your TRUE code to work with suppliers who may not participate with your host. It's a win-win for everyone!**



### REQUIREMENTS FOR OBTAINING A TRUE CODE:

- You must be a corporation, LLC or sole proprietor. If you're a sole proprietor, you'll need proof of a registered DBA, Assumed or Fictitious Name.
- You must be willing to pass a background screening if necessary.
- You must satisfy all seller-of-travel requirements for your state.
- States which currently require a bond and seller of travel license are California, Florida, Hawaii, Iowa, and Nevada.
- You must be able to demonstrate at least 6 months of travel selling experience.
- You must have 3 business references to support your application.
- You must provide proof of an active business bank account in good standing.
